4. Privatization of Integrated Healthcare: Impacts for Whatcom County Discussion

Behavioral Health Integration with Physical Health will happen in Whatcom County in 2019 for individuals covered by Medicaid.

- Whatcom County, together with Snohomish, Island, Skagit, and San Juan Counties will continue to work together regionally as "Mid-Adopters" of the new integrated system.
- The current administrative agency (the North Sound Behavioral Health Organization (BHO)) will largely be replaced by the North Sound BH Administrative Service Organization (BH-ASO), which will play the leading role in coordinating/funding crisis services, but likely will not be responsible for triage/detox services, which are considered outpatient services under the Medicaid contract.
- Non-crisis behavioral health services will be the responsibility of Managed Care Organizations (MCOs), which are a mix of private corporations, a publicly traded corporation (Molina) and a non-profit health center owned organization (Community Health Plan of Washington).
- There is a commonly held belief that the Health Care Authority (HCA), the independent state agency that serves as the purchaser of Medicaid services, is underestimating the cost of these BH-ASO services. Furthermore, there is concern that the HCA doesn't understand the extent of the burden that will be shifted to county governments if service quality drops or new gaps are created.

There are some key areas where HCA, via the county, would benefit from BHAC's input

- The interface of behavioral health and criminal justice
- The importance of transition services for individuals moving from one type of service or residency to another
- The inadequacy of provider networks among some of the MCOs may present more challenges than HCA is anticipating
- The metrics and outcomes that are more important at a county-level

Approaches to Influencing the Integration Process

- Whatcom County has found success through strong relationships with the other counties in the North Sound region; continued collaboration across counties will strengthen our approach
- In SW Washington, where the regional entity integrated care in 2018, MCOs were influenced by a
 desire to protect their reputation in the public eye.
 - Educating the public, explaining how they're likely to be impacted, and then representing and magnifying their voices is a suggested strategy to achieve influence
- Develop a dashboard to monitor the metrics that are important to our county- use this to provide ongoing evaluations and inform system adjustments

	 There will be two attached units: one for acute detox and one for mental health stabilization Each of the two units will have 16 beds and they will share a commercial kitchen 	
	 Existing Crisis Triage facility space will be vacated once new building is finalized, with many worthy causes being considered for future use of that space 	
	A new Medicaid-billing SUD treatment provider will be operating in town soon (Lifeline Connections) on the Guide Meridian
