The permittee shall further hold blameless and harmless and indemnify Whatcom County, its officers, agents and employees against any accident, liability, loss, injury, action and the costs thereof arising from the conductor operations of the permittee in connection with this permit. I further understand that prior to movements the permittee shall establish a routing to safely detour all structures having a limited clearance less than the permitted height.
