1 **Call to Order**

2 The virtual meeting was called to order by Whatcom County Planning Commission
3 Chair, Kelvin Barton at 6:31 p.m.

9 Tammy Axlund from Planning and Development Services; Ann Beck from the Health
10 Department; and Royce Buckingham from the Prosecuting Attorney's Office.

11 **Department Update**

12 Mark Personius, Director of Planning and Development Services (PDS), announced that
13 on Tuesday, July 27th, County Council will hold their final public hearing on the Cherry
14 Point amendments, and we anticipate a decision. Planning Commission
15 recommendations for battery energy storage systems and the Nooksack Falls Exclave
16 are scheduled for Planning and Development Committee and for introduction at Council
17 meeting on Tuesday. If things goes as scheduled, there will be a public hearing on
18 these items in August.

19 PDS is beginning our post-COVID operations plan. Doors are currently closed to walk-
20 in traffic, but as of July 1st, people have been able to schedule an appointment to come
21 in and speak with staff in person. So far we are filling 4 or 5 of the 12 appointment
22 times which are available each day.

23 **Open Session Public Comment**

24 There was no public comment.

25 **Commissioner Comments**

26 Commissioner McClendon provided an update on the Public Participation Ad Hoc
27 Committee, noting that all members of Executive and Council appointed boards and
28 committees should have received a questionnaire. She encouraged all Planning
29 Commissioners to participate in the survey. The Ad Hoc Committee is creating another
30 survey, which they hope to release to the general public in September.

6 interim ordinances relating to temporary homeless facilities, proposed definitions, and
7 proposed regulations.

9 include recreational vehicles." from the definition of "Temporary safe parking area" on
10 page 10.

16 section by changing "100" to "50" and inserting "an individual temporary homeless
17 facility' in place of "temporary homeless facilities."

18 If the motion carries, the first sentence of Section 20.17.040 Capacity of Temporary
19 Homeless Facilities will read: A maximum of 50 people may be housed in an individual
20 temporary homeless facility located in the unincorporated county.


