

**WHATCOM COUNTY
EXECUTIVE ORDER 2005- 01**

Amendment to the 2005 Unified Fee Schedule

WHEREAS the 2005 Unified Fee Schedule lists fees for the Parks and Recreation Department; and,

WHEREAS, since adoption of the 2005 Unified Fee Schedule, additional activities and special events have been identified, which necessitate corresponding user fees be implemented to fund these activities and/or events; and,


WHEREAS, the County Executive is authorized by County Ordinance No.2004-065 to make modifications to the Unified Fee Schedule by Executive Order.

NOW, THEREFORE, BY VIRTUE OF THE POWER VESTED IN ME BY THE HOME RULE CHARTER FOR WHATCOM COUNTY, I HEREBY ORDER, EFFECTIVE FEBRUARY 1, 2005, THAT THE 2005 UNIFIED FEE SCHEDULE SHALL BE AMENDED TO INCLUDE THE FOLLOWING FEES, TO BE LISTED UNDER THE HEADING OF PARKS AND RECREATION DEPARTMENT:
