WHEREAS, on the 9th day of February, 1971, the President declared a "major disaster" in the State of Washington under the provisions of Public Law 606, 91st Congress, as amended; and

WHEREAS, Whatcom County is a public entity within said State,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Whatcom County that the Office of Emergency Preparedness be, and hereby is, requested to arrange to have the appropriate Federal Agency perform the following emergency work essential to the health, safety or welfare of the people and property of this public entity:

Removal of debris and clearance of channel of
Swift Creek (Hardin Creek) located in Sections
33 and 34, Township 40 North, Range 4 East, W.M.

THIS BODY CERTIFIES that, to the best of its knowledge and belief, the requested work is eligible under Public Law 606, 91st Congress, as amended; and agrees to (a) provide without cost to the United States all lands, easements, and rights-of-way necessary for accomplishment of the approved work; and (b) hold and save the United States free from damages due to the approved work.
